

# Software License Agreement 'Standard Time'

## 1. License

The software "Standard Time", including the film data ("Software"), is intended exclusively for private use. Any commercial use is strictly prohibited without explicit written permission. ## 2. Rights

Datenstrudel retains all applicable rights to the Software, including commercial copyrights or intellectual property rights.

## 3. Editing, Adapting and Copying

Decompilation, reverse engineering, editing, or any other modification of the Software/film or the source code of the Software are prohibited with the exception of any use under Copyright Law § 69e (establishing interoperability with other software). It is prohibited to make copies of the Software, except for the purpose of producing a backup copy for private use, which must display the copyright notice of the original disk.

## 4. Providing the download version

The ability to re-download the software is a voluntary service of [www.standard-time.com](http://www.standard-time.com) and can be canceled by [www.standard-time.com](http://www.standard-time.com) at any time. [www.standard-time.com](http://www.standard-time.com) reserves the right to change the data of the opportunity to re-download the software, as well as to temporarily or permanently modify or to interrupt it. For clarification: The possibility of cancellation does not apply to a version of the software, which is already on a personal device of the customer, such as his PC, laptop, etc., after the customer has downloaded it. The warranty claims of the customer (s. § 8) remain unaffected by this provision.

## 5. Liability

- 5.1 Datenstrudel and its legal representatives and agents will be liable to the buyer - on whatever legal grounds – exclusively for damages caused by intent, gross negligence, and negligence and only in case of a breach of fundamental contractual obligations, on the compliance of which the buyer can be expected to rely. In the latter case, liability is limited to the replacement of any typically predictable damage. The foregoing limitation shall not apply in the event that Datenstrudel, its legal representatives or agents cause death or injury to body or health, nor to liability under the Product Liability Act.
- 5.2 For loss or damage of data, liability is limited to the amount of the cost of reconstruction, given the existence of proper backup copies.
- 5.3 Datenstrudel will not be liable for any hardware damage, particularly in monitors (burning-in), or any other damages caused by use of the Software contrary to the recommendations in the Manual.
- 5.4 The restrictions in paragraphs 4.2 and 4.3 do not apply to gross negligence or wilful conduct of Datenstrudel, its legal representatives and agents.
